On September 15, 2022 the Standing Rock Sioux Tribal Council approved to post **Title IV (4), Criminal Offenses/Sex Offenders, 4-508 Simple Assault** and **4-509 Aggravated Assault** of the Standing Rock Sioux Tribal Code of Justice for ten (10) days. Pursuant to Title XIX of the Code of Justice, any interested persons may submit comments on proposed amendments on **Title IV (4), Criminal Offenses/Sex Offenders, 4-508 Simple Assault** and **4-509 Aggravated Assault** the person believes should be amended.

Members of the Judicial Committee, In-House Counsel and counsel retained by the Tribal Court for Code of Justice revisions will accept oral, written and electronic comments until October 2, 2022. You may submit your electronic comments to the following:



**RESOLUTION TO POST REVISIONS TO TITLE IV
4-508 SIMPLE ASSAULT AND 4-509 AGGRAVATED ASSAULT
FOR PUBLIC INSPECTION**

WHEREAS, the Standing Rock Sioux Tribe is an unincorporated Tribe of Indians, having accepted the Indian Reorganization Act of June 18, 1934, with the exception of Section 16, and the recognized governing body of the Tribe is known as the Standing Rock Sioux Tribal Council; and

WHEREAS, the Standing Rock Sioux Tribal Council, pursuant to the amended Constitution of the Standing Rock Sioux Tribe, Article IV, Section 5, shall post all proposed ordinances introduced at a Tribal Council Meeting in each district for not less than ten days prior to final adoption by the Tribal Council for public inspection. All enacted ordinances shall be made available to the Local District Councils; and

WHEREAS, the Standing Rock Sioux Tribal Council, pursuant to the amended Constitution of the Standing Rock Sioux Tribe, Article IV, Section 1[c], is empowered to promote and protect the health, education, and general welfare of the members of the Tribe, and to administer charity and such other services as may contribute to the social and economic advancement of the Tribe and its members; and

WHEREAS, the Tribal Council has received information from Standing Rock Tribal Health that emergency responders are being assaulted and threatened when performing their duties and there is not sufficient protection in the Tribal Code to hold those accountable that engage in violent and threatening behavior against Standing Rock Tribal Employees that are responding to emergencies; and

WHEREAS, The Tribal Health Department has presented revisions to Title IV, 4-508 Simple Assault and 4-509 Aggravated Assault to include criminal penalties for individuals that cause bodily injury to Tribal employees who are on duty; and

WHEREAS, The Tribal Council has reviewed the proposed revisions to Title IV, 4-508 Simple Assault and 4-509 Aggravated Assault and desires to post the proposed revisions for ten (10) days in order to allow for public inspection and comment and to be made available to the Local Districts; and

NOW, THEREFORE BE IT RESOLVED, the Tribal Council hereby approves to post the revisions to Title IV, 4-508 Simple Assault and 4-509 Aggravated Assault for public comment and to be provided to all Local District Councils for ten (10) days pursuant to the Constitution of the Standing Rock Sioux Tribe and Tribal Code; and
