JUSTICE AND INTERIOR DEPARTMENTS SUBMITTED TO CONGRESS IN AUGUST 2011, MAKES CLEAR THAT FACILITIES MAINTENANCE AND REPAIR IS A RESPONSIBILITY OF THE BIA [“STARTING IN FY 2012, FACILITIES MAINTENANCE FUNDING FOR DETENTION FACILITIES WILL BE INCLUDED IN THE PUBLIC SAFETY AND JUSTICE BUDGET WITHIN THE OPERATION OF INDIAN PROGRAMS [OIP] ACCOUNT”].

NOW THEREFORE BE IT RESOLVED, THE TRIBAL COUNCIL HEREBY AUTHORIZES THE BIA OJS TO PROPERLY STAFF, OPEN, OCCUPY, OPERATE AND MAINTAIN THE STANDING ROCK JUVENILE DETENTION FACILITY, A 15,679 SQ. FT., 18-BED, SECURE JUVENILE DETENTION FACILITY, AND TO ADMINISTER NECESSARY SERVICES FROM THE FACILITY, THAT RELATE TO AND ARE ASSOCIATED WITH THE LAWFUL DETENTION AND INCARCERATION OF TRIBAL YOUTH, FOR A PERIOD OF NINETY [90] DAYS FROM THE DATE ON WHICH BIA OJS CORRECTIONS PERSONNEL TAKE ACTUAL POSSESSION OF THE DETENTION FACILITY, BY RESOLUTION.
