NOTICE IS HEREBY GIVEN THAT, IN ACCORDANCE WITH THE STANDING ROCK SIOUX TRIBAL CONSTITUTION AND THE TRIBAL CODE OF JUSTICE THAT A GENERAL ELECTION RETENTION REFERENDUM FOR TRIBAL COURT JUDGES & JUSTICES WILL BE HELD ON THE STANDING ROCK RESERVATION ON SEPTEMBER 24TH, 2025.

THE QUALIFIED VOTERS OF THE ENTIRE RESERVATION WILL VOTE ON THE ISSUE OF WHETHER OR NOT TO RETAIN THE FOLLOWING JUDGES AND JUSTICES OF THE STANDING ROCK SIOUX TRIBAL COURT FOR A FOUR (4) YEAR TERM.

WHO IS QUALIFIED TO VOTE


Any member of the Tribe who (1) is 18 years of age or older, (2) resides on the Reservation, and (3) is eligible to vote in the district in which he has last resided for a full thirty (30) days immediately preceding the election. Prisoners incarcerated in a jail or other correctional facility at the time of voting shall not be eligible to vote. Persons released on parole or probation shall not be deemed prisoners and shall be eligible to vote.
