

PROCLAMATION

OF JOINT TRIBAL ADVISORY COMMISSION ELECTION 2025 SRST GENERAL ELECTION WEDNESDAY, SEPTEMBER 24^{TI}, 2025

IT IS HEREBY PROCLAIMED THAT AN ELECTION WILL BE HELD ON WEDNESDAY, SEPTEMBER 25TM, 2025, ON THE STANDING ROCK SIOUX RESERVATION. THE QUALIFIED VOTERS OF THE DISTRICTS OF: PORCUPINE, ROCK CREEK, RUNNING ANTELOPE AND WAKPALA WILL VOTE TO ELECT A JOINT TRIBAL ADVISORY COMMISSION MEMBER FOR A FOUR (4) YEAR TERM, COMMENCING IN OCTOBER 2025.

ELIGIBILITY FOR OFFICE

To seek the office of JOINT TRIBAL ADVISORY COMMISSION member, a candidate must meet the following qualifications:

- 1. Must be an enrolled member of the Standing Rock Sioux Tribe.
- 2. Must be twenty one (21) years or older.
- Must be a resident of the District from which he/she seeks office for at least one (1) year preceding the date of his/her nomination.
- Must not be delinquent on a debt to the Tribe or to a Tribal Agency as defined in Title XV. 15-102 (g)
 of the Tribal Code of Justice.
- 5. Must NOT have been convicted of a Tribal, State or Federal Felony.
- 6. Must NOT have been dishonorably discharged from the Armed Forces.
- 7. Must NOT be a member of the Standing Rock Sioux Tribal Council.

NOTICE TO PROSPECTIVE CANDIDATES

Any person desiring to be a Candidate for JTAC COMMISSION shall file a Nominating Petition & Notice of Candidacy Form with the SRST Election Staff at the Tribal Election Office, Fort Yates, ND by the Filing Deadline listed below. The Nominating Petition must be signed by at least Five (5) District members from the District in which the candidate seeks office. A non-refundable Filing Fee of (\$100.00) dollars must be paid at the time of filing.

NOMINATING PETITIONS AND NOTICE OF CANDIDACY FORMS CAN BE OBTAINED FROM THE SRST TRIBAL ELECTION OFFICE, LOCATED AT THE TRIBAL ADMINISTRATIVE SERVICE CENTER, FORT YATES, ND OR FROM YOUR DISTRICT ELECTION COMMISSION MEMBERS. VOTERS MAY SIGN ONE OR MORE NOMINATING PETITIONS FOR EACH OFFICE.
