

## **PROCLAMATION**

# SITTING BULL COLLEGE BOARD OF TRUSTEES ELECTION 2025 SRST GENERAL ELECTION WEDNESDAY, SEPTEMBER 24"', 2025

IT IS HEREBY PROCLAIMED THAT AN ELECTION WILL BE HELD ON WEDNESDAY, SEPTEMBER 24<sup>511</sup>, 2025, ON THE STANDING ROCK SIOUX RESERVATION TO ELECT SITTING BULL COLLEGE BOARD OF TRUSTEES FROM THE DISTRICTS OF BEAR SOLDIER, CANNON BALL, KENEL, AND LONG SOLDIER TO SERVE AS THE SITTING BULL COLLEGE BOARD OF TRUSTEES FOR A FOUR (4) YEAR TERM, COMMENCING IN OCTOBER 2025.

#### ELIGIBLITY FOR OFFICE

To seek membership on the SITTING BULL COLLEGE BOARD OF TRUSTEES, the following qualifications must be met:

- 1. Must be an enrolled member of the Standing Rock Sioux Tribe.
- 2. Must be twenty five (25) years or older and possess at least an Associate's Degree.
- Must reside in the District from which he/she seeks office for at least one year preceding and must retain residency in the district through term of office.
- 4. Must not be a full-time permanent employee of Sitting Bull College.
- Must not be a student taking more than five (5) credits per semester through Sitting Bull College or a college with whom there is an articulation agreement.
- Must not have been convicted of a felony or an offense involving dishonesty, by any Court, including any
  offense defined in 18 USC 1163.
- Must not have been dishonorably discharged from the Armed Forces.
- 8. Must not be delinquent on a debt to the Tribe as set forth in Title XV. Section 15-102 (g).
- 9. Must randomly submit to Sitting Bull College employee drug test pool.

### NOTICE TO PROSPECTIVE CANDIDATES

Any person desiring to be a Candidate for the Office of Sitting Bull Board of Trustees shall file a Nominating Petition & Notice of Candidacy Form with the SRST Election Staff at the Tribal Election Office, Fort Yates, ND by the Filing Deadline listed below. The Nominating Petition must be signed by at least Five (5) District members from their respective districts. A Filing Fee of (\$100.00) must be paid at the time of filing.

### MONDAY, AUGUST 25th, 2025 - 4:30 pm (CST) FILING DEADLINE

NOMINATING PETITIONS AND NOTICE OF CANDIDACY FORMS CAN BE OBTAINED FROM THE SRST TRIBAL ELECTION OFFICE, LOCATED AT THE TRIBAL ADMINISTRATIVE SERVICE CENTER, FORT YATES, ND OR FROM THE DISTRICT ELECTION COMMISSION MEMBERS. VOTERS MAY SIGN ONE OR MORE NOMINATING PETITIONS FOR EACH OFFICE.
